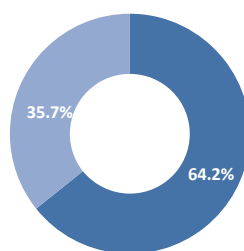

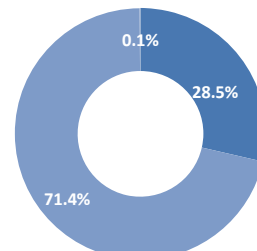

COMPOSITION OF FUND AUM SPLIT BY

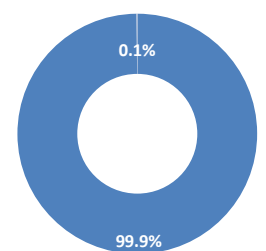
